This policy provides protection for insured entities and members that are held liable for a negligent act that results in property damage or bodily injury anywhere in the world excluding USA and Canada.

Professional Indemnity

Scope of cover

This policy provides indemnity to a coach, referee or official if they are held liable for an error or incorrect advice which results in injury or property damage to a third party.
